BIOGRAPHICAL SKETCH

Ovid Butler (1801-1881) was an Indianapolis, attorney; owner of the Free Soil Banner (1848) and the Indianapolis Journal (1854); and founder and first president of North Western Christian University which later was named Butler University in his honor. Mr. Butler sold twenty acres of his property for the original site of the university.
