#### **BIOGRAPHICAL SKETCH**

Anita Olga Bowser (formerly Anita Olga Albu) was born on 18 August 1920 in Canton, Ohio. She died on 4 March 2007 in Indianapolis, Indiana. Anita married Russell Bowser (19 September 1905 – 27 November 1967) a professor, in 1948. Russell and Anita Bowser taught classes at Purdue University branch campuses in northern Indiana.

Anita Bowser earned five degrees: a Bachelor of Arts from Kent State University in 1945; a Bachelor of Law from McKinley School of Law in 1949; a Master of Arts from Purdue University in 1967; a Master of Arts from Notre Dame in 1972; and a Doctorate of Philosophy from Notre Dame in 1976.

Bowser became a part time instructor at the Purdue Barker Center (which evolved into Purdue North Central) in 1950. She was the first female professor at Purdue University. From 1967 to her retirement in 1991 Bowser was a professor of Political Science at the Purdue North Central campus.

In 1980 Anita Bowser was chosen to be State Representative Clifford Arnold's replacement. She served as a representative from 1980 to 1992. During this time she became the first woman to hold the position of Deputy Speaker Pro Tempore in Indiana's history. In 1992 Bowser was elected State Senator for the 8<sup>th</sup> district, representing LaPorte and St. Joseph counties. Bowser continued to serve as a State Senator until her death in 2007.

Bowser's priorities included education, economic development, health care, and the environment. As a State Senator she tried to remain accessible to the citizens she represented. She was often called "the conscience of the Indiana State Senate." She stood up for civil liberties and women's rights. Anita Bowser made her last speech to the Indiana Senate from a wheelchair a month before she died. Her speech was in opposition to a constitutional ban on same-sex marriage.
