HISTORICAL SKETCH

Cornelius Corwin was born in Jay County, Indiana to William and Mary (Gray) Hudson Corwin. On August 9, 1862, he was mustered into Company E Eighty Ninth Indiana regiment in which he served the duration of the War. Corwin's military career began roughly as the Eighty Ninth was captured by General Bragg in Kentucky within a month of its formation. Released on November 17, 1862, the regiment spent the following year on garrison duty in Memphis, Tennessee, before joining Sherman on the Meridian and Red River expeditions in January 1864. After fighting battles at Yellow Bayou, Vicksburg, and Memphis, the Eighty Ninth helped defeat Confederate General Hood's forces at Nashville in December 1864. They participated in the capture of Fort Blakely in Mississippi shortly before the War's end. On July 19, 1865, Corporal Corwin was mustered out. He returned to New Mt. Pleasant, Jay county, Indiana, and became an attorney, establishing his own firm in 1885.

SCOPE AND CONTENT NOTE

The collection consists of three diaries written by Corwin during his time at War, 1862-1865. The first, a small booklet of approximately eighty pages, is dated October 1863 to May 1864. The remaining two, dated May 1864 to July 1865, are photocopies. The diaries include descriptions of battles, living conditions, and personal happenings as well as news of Lincoln's death. Also included are Corwin's furlough papers dated 1 October 1862 and his discharge papers dated 19 July 1865. A pension notice is dated 29 April 1921.
