#### HISTORICAL SKETCH

Gerresheimer Glass Inc., an international company based in Dusseldorf, Germany, specializes in pharma and life sciences glass and plastic ware. They have 42 locations with plants in Europe, Asia, and the Americas. The company was founded in 1864 by Ferdinand Heye and began becoming more specialized in the 1980s. This company acquired the Kimble-Kontes Company from Owens-Illinois, Inc. in 1997.

Kimble-glass Company was founded by Colonel Evan Ewan Kimble in Chicago. As the company expanded the headquarters was formed in Vineland, New Jersey. Kimble acquired Kontes glass company in 1982.

Owens Bottle-Machine Company was founded by Michael Owens after he invented the automatic bottle making machine in 1903. This company merged with Illinois Glass Company in 1929. In 1965 they became Owens-Illinois, Inc. so their name would encompass their broader productions of glass and plastic ware. This company is an international company that produces a variety of different types of containers. Its trade name is O-I.
