## **BIOGRAPHICAL SKETCH**

George Washington Cross, born in Ohio, served for nearly three years from 1844 to 1847 as the Postmaster of Montezuma, Parke County, Indiana. Recorded in the 1850 Indiana Census as a clerk with an estate of \$1,200, he was also the Montezuma Inspector of Elections in 1845 and 1846.

Eliza Jane Cross, was a resident of Montezuma, Indiana.

Sharon Case, born in Ohio, married Martha J. Cross (daughter of G.W. Cross) May 16, 1866. He was an organizing member of the Montezuma Lodge, No. 37, A.O.U.W. in October 1879.

Nathaniel Wilson was a resident of Montezuma, Park County, Indiana, with Ohio connections.

Addison Dixon, born about 1844 in Hendricks County, Indiana, served as a Private in Co. B., 117 Indiana Volunteers, 23 July 1863-23 February 1864.
