BIOGRAPHICAL SKETCH

This collection represents three generations of the Burford family, which originated in Harrodsburg, Ky., then moved to Missouri and finally to Indianapolis.

Miles W. Burford (d. ca 1875) was born in Harrodsburg, as was his wife Nancy J. (d. ca 1895). They moved to Independence, Missouri, in 1839, and there he became a banker, with connections in Kansas City and St. Louis. In the

1860s he formed a partnership with his son-in-law, <u>William Braden</u>, a printer in Indianapolis. Braden also did some speculating in real estate, and got into trouble in the Panic of 1873. By 1875 he had left town, appointing John R. Elder as trustee to pay off his debts.

One son of Miles W. Burford was John T. Burford (1848-1919), a doctor in Indianapolis.

The most important member of the second generation of the family was <u>William B. Burford</u> (1846-1927). Born in Independence, he came at fifteen on a visit to Indianapolis, before the Civil War. Returning to Missouri, he served during the war in the cavalry of the state militia, fighting guerillas, and also attended college for two years. Coming back to Indianapolis, he worked with his brother-in-law Braden. The partnership of Braden and Burford was dissolved in 1875, and Burford took over the printing business. He held the contract for state printing, did the finest engraving in the state, and ran a fully stocked stationery store. The stationery store was at 36 West Washington St., the printing offices at 40 South Meridian St. Burford also dealt in real estate, and was involved with many civic enterprises which worked to improve and develop Indianapolis.

William B. Burford's daughter, <u>Caroline</u>, married <u>Henry R. Danner</u> (1870-1950), a lawyer who also served as president of the printing firm. The Danners built one of the fine homes on Shooter's Hill, on West 42nd Street just east of Michigan Road. Mrs. Danner was known in her early days for her beautiful clothes, which were exhibited at the Indianapolis Museum of Art in 1979.

The Danners had three children: Burford Danner, who lived in Indianapolis and ran the printing company; Helen, who married <u>William Garrigues</u> and lived in Princeton, New Jersey; and Betty, who married <u>Edward Ridley Finch, Jr.</u>, a New York lawyer.

William B. Burford, Jr. (1889-1937) had two sons, William B. Burford 3rd, a chemist, and Miles G. Burford, an airplane pilot.

The printing company has survived to the present, headed at different times by William B. Burford, Jr., Mr. Danner, his son Burford Danner, and the donor of this collection, William Danner.

SCOPE AND CONTENT

This collection, filling two manuscript boxes and one oversize folder, consists of correspondence, deeds, abstracts, agreements, bills and receipts, covering the period 1836-1942. It is arranged by correspondent, and chronologically within category.

In <u>Box 1</u>, <u>Folders 1-3</u> trace the affairs of Miles W. Burford, his widow Nancy, and his son-in-law William Braden. <u>Folder 6</u> contains material on the estate of John T. Burford, who left bequests to many philanthropic institutions, mainly for women, in Indianapolis.

<u>Folders 7-26 in Box 1</u> show the dealings, mainly in real estate, of William B. Burford. In addition to business properties downtown, these involve a residence on North Meridian Street and lands in Crawford County and in Iowa. <u>Folder 22</u> contains some stock shares and bonds, and <u>Folder 23</u> some material about the printing business.

<u>Folders 1-18 in Box 2</u> contain items relating to Henry R. Danner and Caroline Burford Danner. These include personal and family letters (Folders 1-6), purchase of the Shooters Hill property (Folder 15), and dealings in downtown real estate.

In <u>Folder 22</u> is a deed from Thomas Sharpe to Charles and Jacob Cox, and in <u>Folder 23</u> an 1885 plat of lots on Lake "Mux-Sen-Kuk-Ee."
