HISTORICAL SKETCH

Lee Burns (1872-1957) was born in Bloomfield, Indiana, the son of Harrison Burns, Indiana's legal code writer. He served as a private in the Indiana Volunteer Infantry during the Spanish American War. After attending Butler University, Burns began practice as an architect in Indianapolis in 1910. He was a member of the firm of Burns and Burns, designers of a number of schools and public buildings. A community leader, Burns served as an officer and/or board member for a number of institutions and organizations, including chairman of the Executive Committee of the Indiana Historical Society from 1924-1945. He married Anna Ray Herzsich in 1907 and was the father of two children.

SCOPE AND CONTENT NOTE

The collection contains Burns' personal papers, addresses, and essays. Included are correspondence, reports, and related materials regarding his involvement with the Indiana Historical Society (1915-1954), the Harrison Mansion Restoration Committee (the restoring of William Henry Harrison's home in Vincennes, 1940-1947), and The Last Man's Club (a Spanish-American War veterans group in Indianapolis, 1947-1954). Among the subjects of his essays and addresses were smoking and the problems of use of tobacco, architecture and its role in Indiana History, including South Hall at Wabash College. There are two photographs, 1) a group photograph of the 1947 annual meeting of the Last Man's Club and 2) a photograph ca. 1857 of Grouseland, William Henry Harrison's home. These are stored in Visual Collections under M 582. The collection also contains "Early Architects and Builders of Indiana" (1935), written by Lee Burns, and "Indianapolis, the Old Town and the New" (1923), with text by Burns.
