BIOGRAPHICAL SKETCH

Nathan Smith (fl. 1822-1835) was a New Englander, probably from western Massachusetts, the son of Nathan and Elizabeth (Atwood) Smith. After teaching in Butler County and Erie in Pennsylvania, he worked his way west. He taught for a short while at Lebanon, Ohio, where he married Martha Benham.

By 1822 Smith was in Richmond, Indiana. He taught first at a one-room school there and then in Centerville at an academy which was set up in 1828. By several accounts (including his own) he was a very good teacher, and attracted many students.

Smith apparently taught in Centerville until 1833. He served as probate judge in Centerville from 1832 to 1835, and also set up a woolen mill. One source indicates that he ended up in Orange County, Texas.

Note: There were at least two Nathan Smiths in Richmond at this time. The other was one of the five sons of John Smith, a North Carolinian who settled in Richmond in 1806. This other Nathan Smith was state representative (1836-1838) and state senator (1838-1840). It is not clear which of these Nathan Smiths was Wayne County surveyor from 1833 to 1836 or publisher of the Centerville *Independent Press* in 1852.
